

INVITATION TO BID

Sealed bids will be received by the Creedmoor Maha WSC at 12100 Laws Road, Buda, Texas 78610 at 11:00 AM, on November 17, 2020 and will be publicly opened and read aloud at that time, for constructing the following project:

TWIN CREEKS ROAD WATER SUPPLY LINE REPAIR

The project consists of the construction of approximately 500 linear feet of new 16-inch diameter waterline by horizontal directional drilling along Twin Creek Road, at the Onion Creek crossing in Travis County, Texas.

Bids must be submitted on the complete project. Bids must be enclosed in a sealed envelope, addressed to John Steib, General Manager, and the outside of the envelope must be marked BID ENCLOSED – TWIN CREEKS ROAD WATER SUPPLY LINE REPAIR. All bids must be made on blank forms provided and included in the bound document. The name and address of the Bidder must be plainly marked thereon.

Each bid must be accompanied by cash or a certified cashier's check, drawn on a bank or trust company authorized to do business in the State of Texas, payable to Creedmoor Maha WSC in an amount at least equal to five percent (5%) of the total amount of the bid, as a guarantee that a contract will be entered into. In lieu of cash or a certified check, the Bidder may submit a bid bond in the form prescribed in paragraphs 5.01 and 5.02 of the General Conditions.

A non-mandatory pre-bid conference will be held at 2:00 p.m. on October 28, 2020 at 2:00 PM located at Creedmoor Maha WSC, 12100 Laws Road, Buda, Texas 78610.

Bidding Documents are on file and may be examined at Creedmoor Maha WSC located at 12100 Laws Road, Buda, Texas 78610. Bid Documents and Specifications may be obtained electronically by the prospective bidders or suppliers at www.civcastusa.com at no charge. Neither Creedmoor Maha WSC nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than those issued through CivCast.
