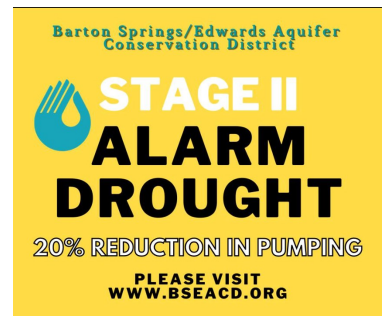

STAGE II—Critical Water Use Restrictions



We are currently going by the Barton Springs/Edwards Aquifer Conservation District water restrictions by requesting our members to reduce water use by 20%.

Mandatory Water Use Restrictions CMWSC will impose on its customers are:

Below are some guidelines we ask our members to follow: Irrigation of landscaped areas with hose-end sprinklers or automatic irrigation systems shall be limited to;

- 1) Addresses ending in 1, 2, or 3 and locations without addresses: **MONDAYS** only
- 2) Addresses ending in 4, 5, or 6 and locations without addresses: **WEDNESDAYS** only
- 3) Addresses ending in 7, 8, 9, or 0 and locations without addresses: **FRIDAYS** only

Irrigation of landscaped areas is further limited to the hours of;

12:00 AM (midnight) until 10:00 AM and between 8:00 PM and 12:00 AM (midnight)

However, irrigation of landscaped areas is permitted at any time if it is by means of a handheld hose, a faucet-filled bucket, or watering can of five (5) gallons or less, or drip irrigation system on designated watering days.

12:00 AM (midnight) until 10:00 AM and between 8:00 PM and 12:00 AM (midnight)

Use of water to wash any motor vehicle, motorbike, boat, trailer, airplane or other vehicle is prohibited except on designated watering days.

Such washing, when allowed, shall be done with a hand-held bucket or a hand-held hose equipped with a positive shutoff nozzle for quick rinses. Vehicle washing may be done at anytime on the immediate premises of a commercial car wash or commercial service station. Further, such washing may be exempted from these regulations if the health, safety, and welfare of the public are contingent upon frequent vehicle cleansing, such as garbage trucks and vehicles used to transport food and perishables.

12:00 AM (midnight) to 10:00 AM and between 8:00 PM to 12:00 AM (midnight)

Use of water to fill, refill, or add to any indoor or outdoor swimming pools, wading pools, or Jacuzzi type pool is prohibited except on designated watering days.

Operation of any ornamental fountain or pond for aesthetic or scenic purposes is prohibited except where necessary to support aquatic life or where such fountains or ponds are equipped with a recirculation system.

Use of water for the irrigation of golf courses, parks, and green belt area is prohibited except by hand-held hose and only on designated watering days between the hours 12:00 midnight and 10:00 a.m. and between 8:00 p.m. and 12:00 midnight.

The following uses of water are defined as nonessential and are prohibited:

- Wash down of any sidewalks, walkways, driveways, parking lots, tennis courts, or other hard-surfaced areas.
- Use of water to wash down buildings or structures for purposes other than immediate fire protection.
- Use of water for dust control (unless dust control is a requirement of a specific TCEQ permit).
- Flushing gutters or permitting water to run or accumulate in any gutter or street. Failure to repair a controllable leak(s) within a reasonable period after having been given notice directing the repair of such leak(s).
- Any other waste of water.
